

Documentation of parameters of the mBank CompanyNet system – explanations and footnotes

mBank CompanyNet System Customer's Access Rights Card, New definition

a. Explanations:

2. Set up a holding structure:

In order to set up a holding structure with the participation of entities other than the customer, the customer has to provide the bank with documents which prove the customer's right to manage accounts of entities other than the customer (which are to be included in the holding structure), and the bank has to grant its consent in writing.

mBank CompanyNet System User Card

a. Explanations:

9. Custody module (The granting of rights to the Custody module requires additionally the completion of the Custody User Rights Card. In the case when the person is not an authorised mBank CompanyNet system user, the customer is obliged to file the mBank CompanyNet system user card, constituting the base to open the user account in the mBank CompanyNet system. Detailed information on providing the Custody functionality is provided by employee of the bank).

10. Developer Escrow Accounts module (to be granted authorizations to the Developer Escrow Accounts Module, the user needs to fill out the Authorization Card of the Developer Escrow Accounts service user. If the person is not a user of the mBank CompanyNet system, the customer is obliged to submit the mBank CompanyNet user card. Detailed information on provision of the service is given by the employee of the bank).

- 2/ Appendix no. 1 "Authorization scheme card".

- 9 If the customer selects option C – "Conclusion", authorisations to V – "View" and to conclude transactions by phone are automatically granted.
- 10 Functionality tied to the reports.
- 11 The management of prepaid cards and prepaid card instructions are made available to the Customer only upon the Customer's explicit request (in agreement with the Bank's employee).
